COPYRIGHT LICENSE AGREEMENT

THIS LICENSE AGREEMENT (this "Agreement") is made and entered into effective as of the 10 day of Octorber, 2012, by and between Sri Contents ("Licensor") and TheCinebay Partnership Firm. ("Licensee").

RECITALS

- A. Licensor owns the copyright, title, trademarks and all other related rights in and to the work, images and videos related to Indian movies which (hereinafter "Material"). 1. Rights Granted.

- A. Licensor hereby grants to Licensee, its successors and assigns, an exclusive right, license and privilege worldwide (the "Territory")
- B. Licensor hereby grants to Licensee, in accordance with the terms and conditions of this Agreement, a (non)-exclusive, non-transferrable license to use the Work in the course of its business and to otherwise copy, make, use and sell the Work. Licensee may copy and sell the Work in accordance with the terms set forth below, for uploading on the website www.thecinebay.com, www.youtube.com and www.dailymotion.com.
- B. Licensee hereby accepts such license and agrees that Licensee shall not use the Work except in accordance with the terms and conditions of this Agreement. Licensee acknowledges and agrees that the license granted herein is non-exclusive and that Licensor may license others to use the Work subject to any limitations set forth herein.

2. Licensor's Rights and Obligations.

a. Licensor warrants and represents that it owns all right, title and interest in and to the Material.

3. Licensee's Rights and Obligations.

a. Licensee shall be solely responsible for providing all funding and technical expertise for the development and marketing of the Material.

4. Payments.

- a. For the rights granted by Licensor herein, Licensee shall pay to Licensor a royalty calculated as follows:

5. Warranty and Indemnification.

a. Licensor warrants and represents that it has the full right, power and authority to enter into this Agreement and to grant the rights granted herein; and that Licensee's inclusion and use of the Material will not violate any rights of any kind or nature whatsoever of any third party. Licensor shall indemnify and hold harmless Licensee, its successors, assigns and licensees, and the respective officers, directors, agents and employees, from and against any and all claims, damages, liabilities, costs and expenses (including reasonable attorneys' fee), arising out of or in any way connected with any breach of any representation or warranty made by Licensor herein.

6. Term and Termination.

- a. The term of this Agreement shall be fifteen (15) years from the date of execution by both parties, unless terminated earlier pursuant to this section.
- b. This Agreement shall be subject to termination by written notice by either Licensor or Licensee.
- c. Upon termination or expiration of this Agreement, Licensee shall cease reproducing, advertising, marketing and distributing the Material as soon as is commercially feasible.

7. General Provisions.

a. Successors/Assigns.

This Agreement is binding upon and shall inure to the benefit of the respective successors and/or assigns of the parties hereto.

b. Integration.

This Agreement sets forth the entire agreement between the parties with respect to the subject matter hereof, and may not be modified or amended except by written agreement executed by the parties hereto.

d. Notice.

The address of each party hereto as set forth below shall be the appropriate address for the mailing of notices, checks and statements, if any, hereunder. All notices shall be sent certified or registered mail and shall not be deemed received or effective unless and until actually received. Either party may change their mailing address by written notice to the other.
